Allowing Junior Translator and Senior Translator of Rajbhasha Cadre for Sub: appearing in SAS Examination-regarding.

Sir/Madam,

Consequent upon the creation of Centralized Rajbhasha Cadre, the Competent Authority vide circular No. 19 Staff Apptt-IV/2018 issued vide letter No. 58 Staff Apptt.II/89-2016 dated 02.7.2018 (copy enclosed) has allowed Junior Translators and Senior Translators for appearing in SAS Examination.

- As per para 2 (B) i and ii of above said circular, the Rajbhasha cadre officials are permitted to choose any stream of SAS i.e. Civil Account, Civil Audit, Railway Audit, Defence Audit, Commercial Audit and Post and Telecommunication Audit, even though the officials are not presently posted in the offices of the stream he/she opts for.
- In terms of para 2 (A) ii of above said circular, option to choose a different stream of SAS examination in respect of officials who have already appeared in SAS Examination shall be as per laid down procedure for the same, but within the stipulated number of chances permitted under the rules in vogue (including those attempts already made).
- In terms of para 1 of circular No. 20 of 2019 of Examination Wing of Headquarters, Junior Translators and Senior Translators of Rajbhasha cadre (All India Cadre) who will register for the first time for appearing in SAS Main Examination 2020 shall be allowed to choose any branch irrespective of the office where they are serving at present. However, officials of the Rajbhasha cadre (All India Cadre) who had earlier registered for SAS Examination in a particular branch will be allowed to appear in that branch only unless they have obtained permission for switch over of branch from Headquarters' Office.
- In terms of Examination Wing Circular No. 15 of 2019, permission for switch over 5. of branch shall be granted by the Director General (Commercial) in case of switch over to Commercial Audit and in other cases by the Director General (Examination).

- 6. As the Rajbhasha cadre (All India Cadre) is maintained by the Staff Wing. Headquarters' Office, applications in the prescribed format for switch over of branches appearing in SAS Examination 2020 in respect of the officials belonging to this cadre are required to be forwarded to the Cadre Controlling Authority i.e. Director General (Staff) for consideration and recommendation.
- 7. Permission for switch over of branch once granted shall be final and request for reverse switch over or multiple switching over shall not be entertained.
- 8. On passing the SAS examination, the official shall be considered for appointment in AAO cadre in any of the offices where vacancies exist in the chosen stream on deputation cum absorption basis. This shall be similar to the existing policy as applicable to officials of A&E offices on passing the SAS (Civil Audit) examination.
- 9. The Rajbhasha cadre officials who will register for the first time and opt to appear in a stream of their choice shall be assigned a nearby office of that stream from where the official shall undergo training and appear in SAS Examination. Such officials will have to register as a candidate in that stream after passing the SAS (Preliminary) Examination.
- 10. Officials of Rajbhasha cadre (Junior Translators and Senior Translators) intending to appear in the SAS Examination-2020 may be asked to communicate their choice of stream in the format enclosed (Annexure-I) in duplicate. The office may verify the details, retain one copy of the option for record and forward the other copy to Staff Wing latest by 20<sup>th</sup> March, 2020 duly verified by the Group Officer in charge, alongwith the information as per Annexure-II.
- 11. The option received after the stipulated date i.e. 20th March, 2020 will not be considered.
