

## OFFICE OF THE ACCOUNTANT GENERAL (G&SSA) ODISHA: BHUBANESWAR CIRCULAR

Sub: Calling for application from the intending fresh candidates to appear Preliminary Test in order to qualify for forth coming SAS Annual Examination -2020 (of both Civil and Commercial Audit Branches).

- 1. Eligible officials of three offices of Accountant General (G&SSA) Odisha. Pr. Accountant General (E&RSA), Odisha and Deputy Director, O/o the Director General of Audit (Central), Hyderabad, Odisha Branch, Bhubaneswar intending to appear at the SAS Annual Examination of both Civil & Commercial Audit Branches 2020, may apply for the Preliminary Test for qualifying Annual Examination. They may submit their applications in the prescribed proforma appended to this circular through proper channel so as to reach Trg.& Exam. (G&SSA) Section on or before 13.03.2020 positively.
- 2. The following categories of officials who would be completing two years of continuous service and would be completing probation period as on 01.09.2020 in a particular field office. The candidates may note that, in case of failure to complete the probation period successfully on the first day of the month in which SAS-2020 (Main) Examination is scheduled i.e 01st September-2020 the candidature of such officials would be cancelled. This would however, not be counted as an attempt at the SAS Examination.
  - i) Clerks having passed Departmental skill Test
  - ii) Auditors / Sr . Auditors
  - iii) Data Entry Operator( Pay Band-1-Grade-Pay-2400/-)/Level-4
  - iv) Stenographer Pay band –I/Personal Assisitnats Pay Band-II/Private SecretaryLevel-4/6/7
  - v) Junior Translator/Sr. Translator
  - vi) Supervisors (Pay Band-II, Grade Pay Rs.4600/-)/Level-8
- 3. The category of officials at Sl. No. (vi) abovei.e. Supervisors (Pay level 8) will be eligible to appear at SAS Exam.2020 and onwards, subject to the fulfillment of the prescribed usual conditions including:-
- a) They have to duly qualify in the preliminary test to be notified in due course.
- b) In the event of passing the SAS Exam., they have to seek reversion in writing to the post of Sr.Audiotrs. For this purpose, they are required to give an undertaking in the application form that they will seek such reversion.

Candidates who had qualified in the preliminary test last time or earlier but failed to appear in SAS examination immediately will have to appear preliminary test again.

- 4. The DAG (ES-II), Puri may kindly record a certificate on the applications in respect of the clerks to the effect that they have passed Departmental Skill Test on Computer after due verification from their respective service Books / relevant records at their end. Applications received after due date will not be entertained under any circumstances. Incomplete applications will summarily be rejected.
- 5. **Important:** As per Hqrs Circular No.6 of 2010 issued vide No.509/44-Exam/circulars/2010 Dated: 03/09/2010, Candidates who have exhausted six chances in terms of Para 9.2.10 of CAG's MSO (Admn) Vol. I and are debarred from the examination are also allowed as fresh candidates without carrying forward the exemption in any paper. Such candidates have to clear the preliminary test as per Para 9.2.4 CAG's MSO (Admn) Vol. I.
- 6. All the fresh candidates who will come out successful in Preliminary Test will have to undergo and complete the prescribed pre-examination training. There shall be two papers for Preliminary Test i. e.

For Civil Audit Branch

- a) Paper –I General English (Language Skills) / Hindi and Constitution of India (also includes CAG's DPC Act, 1971)
- b) Paper –II Service Regulation, Financial Rules and Principles of Govt. Accounts. <u>For Commercial Audit Branch</u>
- a) Paper -I Same as for Civil Audit Branch
- b) Paper-II Service Regulations, Financial Rules and Principles of Govt. Accounts, Commercial Auditing and Commercial Laws & Corporate Tax.
- 7. All the Group Controlling Sections are required to circulate the office order among field staffs under therir control.

The date of Preliminary Test including the detailed programme, Venue of the Test and list of eligible candidates will be notified in due course.
